SIB SELF-EVALUATION:

The ERC reviewed the results of the SIB's self-evaluation. One board member did not complete the survey. Overall the results were positive.

Areas of improvement noted were, (1) meeting attendance, (2) all members should actively participate in discussions and hear all perspectives, and (3) understanding Board versus staff roles.

Past three-year trends, (1) board attendance, (2) understanding what authority has been retained by the Board and what has been delegated to staff, and (3) all board members need to be vocal and make sure their voice is heard during meetings.

General comments made, (1) the SIB is effective and well informed, (2) staff is very effective in communicating, (3) SIB is a strong board with a commitment to governance and fiduciary duty, (4) board members need to avoid self-promoting activities and respect the role as board members.

The ERC requested an attendance roster for the past two-years.

Based on some of the comments, Ms. Sauter suggested additional governance training on board role versus staff role may be beneficial to the Board. The ERC will make the recommendation to the SIB at their next regularly scheduled meeting.

Ms. Sauter will present the results of the self-evaluation at the SIB's March 26, 2021, meeting.

PROCESSES/TIMELINES:

The ERC reviewed the processes and timelines for the Executive Director/CIO annual performance review.

The ERC felt the assessment tools utilized in the past have been sufficient and have provided the ERC with the information they need to provide a fair assessment of the Executive Director/CIO's performance.

EXECUTIVE DIRECTOR/CIO ASSESSMENT TOOLS:

The RIO employee survey of the Executive Director/CIO will be distributed Thursday, March 18, 2021, with a due date of Tuesday, March 23, 2021.

The SIB survey of the Executive Director/CIO will be distributed Wednesday, March 24, 2021, with a due date of Friday, April 2, 2021.

The Executive Limitations audit was completed and distributed to the SIB Audit Committee at their February 25, 2021, meeting, and to the SIB at their February 26, 2021, meeting.

The Executive Director/CIO will also conduct a self-evaluation.

COMPENSATION SURVEYS AND SOURCE/AVAILABILITY OF COMPENSATION COMPARISONS:

The ERC discussed compensation surveys.

Ms. Sauter suggested the SIB be given the McLagan 2020 report at their March 26, 2021, meeting so they have the results of compensation trends for an Executive Director/CIO before the ERC submits their compensation recommendation to the SIB. The ERC concurred.
