GOVERNANCE:

Special AAG Appointment Process:

Ms. Murtha provided an overview of RIO's past and current policy and process related to attorney selection and participation in securities litigation. Both in the past and currently, there is not a formal attorney selection process in place, rather attorney selection is handled on a case-by-case basis. Mr. DePountis provided an overview of his research related to the practices of other pension funds. The first practice is to issue a request for proposals (RFP) and select a single litigation firm that would also provide monitoring services, typically at no additional cost. The second practice is to issue an RFP and select multiple litigation firms that would all provide monitoring services, typically at no additional cost. This could result in added objectivity due to multiple perspectives, and possible cost savings due to competing bidders. Advantages to both the first and second practices include cost savings related to free monitoring services and the convenience of built in representation. The third practice is to have a separate, arguably objective, monitoring service firm, and establish a roster of litigation firms from which we can request bids as cases arise. The fourth and final practice is our current practice: have a separate monitoring service firm, and as cases arise reach out to litigation firms, we either have a relationship with or as recommended by the monitoring service firm.

Staff recommends a more defined process and revisiting the procurement process for the monitoring services firm. Additionally, staff would be comfortable issuing an RFP to establish a roster of litigation firms but would like committee feedback related to utilizing a separate monitoring service firm. Committee discussion followed.

Staff will bring forward a draft RFP for consideration at the next regular committee meeting to establish a roster of litigation firms. During the RFP selection process, staff will also schedule presentations from Northern Trust, custodian bank, and FRT, monitoring services firm, to provide additional information to the committee.

Securities Litigation Monitoring Report:

Mr. Skor reviewed the most recent status report from the monitoring firm FRT. The Committee was provided with a Status Report for the period from May 1, 2023, through May 31, 2023. The report summarizes security litigation activities including newly filed claims, status of previously filed claims, and a summary of the total net recoveries for the period. Committee discussion followed.
