COMMITTEE SCOPE DISCUSSION:

Dr. Lech discussed the status of the Chief Investment Officer (CIO) search and the scope of the Committee's responsibility after the SIB split the Executive Director (ED)/CIO position. The Committee was established to search for the combined position, but can continue to work on the search for the CIO while recognizing that in the future, the ED would be responsible for hiring a new CIO. RIO staff would like the Committee involved in this CIO search. The Committee will also need to address governance and salary issues for the CIO and ED positions.

The Committee discussed its role in determining the compensation range for the CIO position and how this will compare to the ED compensation level. The Committee will provide a recommended range which will be approved by the SIB. Staff discussed the CIO role with Human Resource Management Services (HRMS) and they indicated that the CIO position would be unclassified. The Committee was in agreement that this committee along with the SIB will continue to be involved in the hiring process for the new CIO.

CHIEF INVESTMENT OFFICER (CIO) POSITION SPECIFICATIONS:

Ms. Murtha discussed the CIO position specifications. RIO staff have reviewed the specifications and all comments or questions have been incorporated or addressed. Once approved by the Committee, the specifications will be made available on the RIO website and other appropriate locations. The specifications will not be placed on the ND state job listing site because all applicants will be handled by the executive recruiter, EFL.

CIO COMPENSATION RANGE:

Ms. Murtha provided information about the Chief Investment Officer (CIO) compensation range. The SIB split the Executive Director (ED)/CIO position and this Committee is continuing to assist with the recruitment process for a new CIO. The budgeted amount for the combined position during the current biennium was \$271,456. Staff recommends that amount as the cap for the CIO position. The SIB will need to address the CIO compensation before the next legislative session because this amount is still below market levels. The salary structure will put the CIO higher than the ED.
