New Electronic Communications Tool



The next time you receive this newsletter, it will look different. Why? Because later this spring, communications from TFFR will begin using GovDelivery, a messaging platform built exclusively for use by government agencies.

Our messages will still land in your inbox; they will just have a new look. We will use GovDelivery to send "Briefly" and will use it

to communicate with you about educational events and to share program updates.

The TFFR staff will message you in our usual manner before we spring the new format on you, so you know these new communications are from us.

Save the Date: Retirement Education Workshops in July

Retirement Education Workshops (REW) help TFFR members in mapping to their eventual retirement by providing information on their benefits, estate and financial planning presentations, and a discussion of health insurance options. The employees who benefit most from these workshops are within 1-10 years of retirement. TFFR will host a face-to-face workshop in Fargo on July 19 and a virtual workshop on July 25. The content will be the same for both events. The virtual workshop will be recorded. For individuals who prefer a face-to-face event, TFFR plans to rotate locations, hosting a REW in western North Dakota in 2024. Registration information for the 2023 events will be provided in early May.

Signup for ACH Payments Now, Save Time and Money

TFFR is rolling out a new Pension Administration System in fall 2024 that will require your fund payments be made via Automated Clearing House (ACH).

To ensure a seamless transition to the new system, TFFR invites you to start transferring your funds electronically now.

Making payments with ACH will save you time and money by eliminating manual check cutting and mailing. It also offers increased security and fast delivery.

Fiscal Year-End Reminders Checklist

- ✓ All member records, including reemployed retirees, must be closed with compensated hours and last date worked on the final report.
- ✓ Active Members: compensated hours should be capped at 700 hours.
- ✓ Reemployed retirees: do not cap hours. Report actual compensated hours, even if it exceeds 700. Do not report reemployed retirees' extra-curricular, professional development, and in-staff subbing hours.
- ✓ Part-time teachers: calculate by taking hours worked per day X number of days worked. Part-time teachers are capped at 700 hours.
- ✓ Salary needs to be reported when earned and not when paid. Members contracted over 9 months, but paid over 10, 11 or 12 months, must be expensed out on the June report which is due by July 15.
- ✓ Summer programs salaries need to be reported when earned and not when paid. Report June work on the June report, and July work on the July report. (See June -July Reporting of Hourly Wages on page 4.)
- Unused sick, person and/or vacation leave should **not** be reported to TFFR.
- ✓ No contributions to report, please notify TFFR by e-mail, <u>rio@nd.gov</u>, so we don't send you a late notice.

June-July Reporting of Hourly Wages

Summer reporting isn't routine and it can be confusing. Adhere to the following for best results.

Salary should always be reported in the fiscal year earned, not when paid. If you have Summer School teachers or Drivers Ed instructors, their hours worked in June are reported in June and their hours worked in July are reported in July.

If a salary gets reported in the wrong fiscal year, contact TFFR so we can move the salary to the correct year. If the contribution rates between the two fiscal years are different, we will also correct the over and under payment of contributions.

If you see pay that belongs in a prior year, don't add it to you regular July payroll. Contact TFFR to discuss the best way to report it. If needed, we can do it as a manual entry and avoid having to do an adjustment.

Are you changing Models for 2023-24?

If your TFFR employer payment plan model is changing, i.e., a different model or a change in the amount of pickup under Model 2 Partial, TFFR requires you to complete and return an <u>Employer Demographics and Payment Plan Model</u>.

Model changes must be implemented at the beginning of the fiscal year, on July 1, and must cover all your TFFR members. Administration cannot be covered under a different model.

To ensure the associated reporting is accurate, TFFR requires Employer Demographics and Payment Plan Model form be submitted by July 1.

Tell us about life before you joined the Retirement and Investment Office team?

Pension Administration Project Update

The development of the new TFFR pension administration system continues to move full steam ahead. We are happy to report that the project is on schedule and on budget. Our target date for the switch to the new system is still fall 2024.

Some features of the new system that will benefit employers include the ability to run model change simulations themselves and streamlined reporting with an error check that makes corrections at the time of upload. The employee enrollment function will also be streamlined.



Starting this fall, TFFR is partnering with North Dakota's School Board Association and the Council of Educational Leaders to host educational sessions intended to prepare you for the switch to the new pension administration system. We are also partnering with software vendors and developers of the school systems' software platforms to develop interfaces between your software and our new pension software.

We know there will be some bumps as we adapt to these changes. In the long run, we believe the new system will create efficiencies and ease for both employers and our members.

Retired Member Reemployment

The Education Standards and Practices Board has once again declared all subject areas as critical shortage, **except** for Administration, for the 2023-24 school year. If you employ a retired TFFR member, a <u>TFFR Retired Member Employment</u> <u>Notification</u> form must be completed. PAGE 8

TFFR Forms Shortcuts

- Employing a new teacher, TFFR will need a new <u>Member Action</u> form and a <u>Designation of Beneficiary</u> form. Please note: Only ND licensed teachers are eligible to become members of TFFR. If you employee a teacher who has a permit or sub-license only, they should NOT be reported to TFFR.
- Employing a TFFR retiree, please make sure to complete the <u>TFFR Retired Member</u> <u>Employment Notification</u> form. This form must be completed each year a retiree is employed and submitted to TFFR no later than 30 days after employment begins.
- Change of address or a name change, the TFFR member needs to complete and sign a <u>Change of Name or Address</u> form.
- Best practice recommendation: always use the forms available on RIO's website, <u>https://www.rio.nd.gov/teachers-fund-retirement-employers</u>. Printing and filing our forms puts you at risk of using outdated materials that may require TFFR to ask you to complete a form again.
